Brief Description : **Completion of the Senior Citizen's Building located at at the Municipal Agriculture Office Compound, with works includes: 1) CHB laying, 2) Plastering, 3) Tile Works, 4) Concrete Works, 4) Roofing System , 5) Doors and Windows, 6) Sewerline, 7) Waterline, 8) Septic Vault,. 9)Electrical Works, and 10) Handrails.**
Approved Budget For the Contract (ABC) : **Five Hundred Thousand Pesos (Php 500,000.00)**
Construction Period : **Forty (40) calendar days**

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility Forms) available for the execution of the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids. The BAC will conduct post-qualification of the lowest calculated bid.

All particulars relative to j Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).

The BAC will issue to prospective bidders Eligibility Forms at BAC Secretariat, Office of the Municipal Budget Officer upon their submission of a LOI, and upon their payment of a non-refundable amount of Five Hundred Pesos (**Php 500.00**) in the form of cash to the Municipal Treasurer's Office. Prospective bidders shall submit the Eligibility Requirements to the BAC at the said address. They may also obtain the results of the Eligibility Check by the BAC at the same address.

The BAC will issue Bidding Documents only to bidders declared by the BAC to be eligible for the bidding upon payment of a non-refundable amount of One Thousand Five Hundred Pesos (**Php 1,500.00**) in cash to the Municipal Treasurer's Office from **February 23 to March 1, 2013**.
